Dear Parents/Carers,

**Chessington World of Adventures – Friday 14<sup>th</sup> July 2017**

I am pleased to confirm that tickets have now been reserved for our Year 6 Chessington visit on Friday 14<sup>th</sup> July. The cost of the visit is priced at £30 per pupil. As this is not an educational visit, we are unable to subsidise the cost for parents. Pupils in receipt of free school meals have the option of collecting a packed lunch from school should they wish. Any pupils in possession of a Merlin Card are allowed free entry to the park as usual and will only be charged the coach fee of £16 but they **must** bring their card with them on the day of the trip or risk being charged an “on the spot” full entrance fee.

Please complete the attached reply slip and return to school with payment by Friday 26<sup>th</sup> May. Reply slips and payment will not be accepted after this date. Payment can be made by cash, cheque or online sQuid Payment Account. (Cheques to be made payable to ‘**The Shared Learning Trust**’). If sufficient funds are not received the visit may not go ahead.

The proposed details of the visit are as follows:

- 7.45 a.m. - arrive at school and register
  - 8.00 a.m. - depart school
  - 9.30 a.m. - arrive at Chessington World of Adventures and register with staff
  - 12.30 p.m.-1.30 p.m. – check point with school staff
  - 3.00 p.m. – meet at coach
  - 3.15 p.m. – 3.30 p.m. – depart Chessington World of Adventures
  - 5.00 p.m. – 5.30 p.m. arrive back at school (depending on traffic)
- (Should this time change we will notify parents by text)

If a child’s conduct in school in the remaining weeks of this term does become a concern for their participation in the visit, parents will be contacted and a meeting arranged to put measures in place before any decisions are made. We will be operating a three strike system and if pupils achieve three strikes for inappropriate behaviour, they will be withdrawn from the visit. Pupils are required to act responsibly throughout the day, with high expectations of good manners in dealing with members of the public.

As this is an end of year event, pupils are welcome to wear their own clothes rather than school uniform. Whilst pupils are welcome to bring cameras (we suggest disposable cameras), all items are to remain the responsibility of the child, as staff are unable to guarantee the opportunity to look
