Year 1 – Stockwood Discovery Centre Visit

On Wednesday 15th March Year 1 will be visiting Stockwood Discovery Centre, Luton to have a look at their transport collection. The children will be able to explore different forms of transport and will take part in a workshop which will provide them with additional information surrounding this topic.

The cost of this trip will be £3 which will cover the minibus transport and insurance. Tiger's class will be going to Stockwood Discovery Centre in the morning and will be leaving school at 9.15 a.m and returning at lunch time. Giraffe's class will go to Stockwood Discovery Centre in the afternoon and will return in time for normal collection at 3.15pm.

Payment can be made by cash or cheque. (Cheques to be made payable to 'The Shared Learning Trust'.) Payments can be made to Sharnie Monday-Friday 8.35-9.00 a.m. or 3.00-3.15 p.m. in the Dining Room.

All the children will be required to have a packed lunch on this day that is in a named disposable bag. Due to timings the children will not be able to have a school lunch and instead we will have a picnic together in our classes, normal rules for packed lunches apply.

As we will be travelling in the school mini buses the children are required to have a booster seat. The school will be able to supply some of these, however, if you have a booster seat that you can send your child to school with on the day that would be very helpful.
