### SWIMMING LESSONS AT LEWSEY POOL

Pupils in Year 3 will have the opportunity to attend swimming sessions at Lewsey Park. Pupils in **3KM will commence swimming on Monday 11<sup>th</sup> September** for a 30 minute session over a twelve week period. (September - December 2017). The lesson will be 10.30 a.m.- 11.00 a.m. The cost will be £48 which covers twelve 30 minute swimming lessons. We only require payment from 3KM at this stage. Pupils in 3FW will commence swimming in Spring Term 1 (January - April 2018). We have booked three instructors to cater for all levels and providing transport by minibus. Payment can be made by cash, cheque or online sQuid Payment. (Cheques to be made payable to 'The Shared Learning Trust'). It would be appreciated if payment could be sent in by 6<sup>th</sup> September.

Swimming is a National Curriculum requirement and, as mentioned above, we are providing appropriate instruction for all levels of swimming. **All permission slips must be returned to school by Wednesday 6<sup>th</sup> September.** Children would need to bring in their swimming costumes and towel. We will provide weekly reminders for your child to attend. If your child forgets their kit they will not be able to attend the swimming session.
